**RESOLUTION APPROVING CONTRACT MODIFICATION #2 FOR
CONTRACT WC2508FO-1 TO VAN CLEEF ENGINEERING ASSOCIATES
FOR CONSTRUCTION INSPECTION SERVICES ON AN ON-CALL BASIS
FOR UTILITY PERMIT WORK ON VARIOUS COUNTY ROUTES AND
STRUCTURES FOR NET INCREASE OF \$17,000.00 AND REVISED
CONTRACT AMOUNT OF \$39,000.00**

WHEREAS, the County requested proposals to be received on Thursday, February 27, 2025 for Contract #WC2508FO for Construction Phase Engineering/Inspection Services; and

WHEREAS, this contract is awarded in accordance with N.J.S.A.19:44A-20.4, as a fair and open contract; and

WHEREAS, additional inspection hours are needed to complete the project for a net increase of \$12,000.00; and


WHEREAS, adequate funds are available in account 40165 5100 ETWN 4834 and certified by the County Chief Financial Officer.
