**RESOLUTION AWARDING CONTRACT #WC2508FO-4 TO VAN CLEEF
ENGINEERING ASSOCIATES, LLC FOR CONSTRUCTION INSPECTION
SERVICES FOR AN ON-CALL BASIS FOR UTILITY PERMIT WORK FOR
THE WARREN COUNTY ENGINEER'S OFFICE ON VARIOUS COUNTY
ROUTES AND STRUCTURES IN THE CONTRACT AMOUNT OF
\$22,000.00**

WHEREAS, the County requested proposals to be received on Thursday, February 27, 2025 for Contract #WC2508FO for Construction Phase Engineering/Inspection Services; and

WHEREAS, inspection services are needed for New Jersey American Water utility related permit construction work; and

WHEREAS, this contract is awarded in accordance with N.J.S.A.19:44A-20.4, as a fair and open contract; and

WHEREAS, the proposal submitted by Van Cleef Engineering Associates, LLC meets the needs of the program, price and other factors considered in the amount of \$22,000.00; and


