RESURFACING AND REHABILITATION OF COUNTY ROUTES #519,
#625, #628, #632, #633, #649 & #681, FRANKLIN, FRELINGHUYSEN,
GREENWICH, HARMONY, POHATCONG, WASHINGTON & WHITE
TOWNSHIPS FOR NET INCREASE OF \$10,000.00 AND REVISED
CONTRACT AMOUNT OF \$94,000.00**

WHEREAS, the County requested proposals to be received on Thursday, February 27, 2025 for Contract #WC2508FO for Construction Phase Engineering/Inspection Services; and

WHEREAS, inspection services are needed for the above project; and

WHEREAS, this contract is awarded in accordance with N.J.S.A.19:44A-20.4, as a fair and open contract; and

WHEREAS, additional inspection hours are needed to complete the project for a net increase of \$10,000.00; and


WHEREAS, adequate funds are available in accounts 0425A101 5063 certified by the County Chief Financial Officer.
