Bids will be made on standard proposal forms in the manner designated therein as required by the specifications and supplementary specifications, must be enclosed in envelopes (outer and inner), both of which shall be sealed and clearly labeled with the words CONTRACT BID DOCUMENTS, project number, name of Bidder and date and time of bid opening, and addressed to Marie Watters, Director of Purchasing, Wayne Dumont, Jr. Admin. Bldg., 165 Rt. #519 So, Belvidere, NJ 07823. All bids must be accompanied by a certified check, bank draft, or bid bond and made payable to the order of Warren County Treasurer's Office, in the amount of at least ten percent (10%) of the total bid; provided said check or bid bond shall not exceed \$20,000.00.

We strongly recommend that the contractors attend the pre-bid meeting which will be conducted on-site on March 24, 2026 at 10:30 a.m. Only three (3) representatives will be allowed to represent the bidder at this pre-bid meeting.

The Board of County Commissioners reserves the right to reject any and all bids and to waive any minor irregularities or informalities in the bids.
