Your voting district and polling location will be shown on the outside front of your SAMPLE BALLOT which you will receive shortly before the election.

You will find a NJ Voters' Bill of Rights posted at your polling place. The Bill of Rights addresses the following matters: Interaction with the voting machine, ID requirements for first-time voters, Vote by-Mail registrants, Provisional ballot voting, Challenger do's & don'ts, Challenge process in the polling place, Election offenses, and Exit polling questions. A copy of the NJ Voters' Bill of Rights may be obtained before Election Day by calling 908-475-6313 or 6314 between the hours of 8:00am and 4:30 pm Monday through Friday.

CHANGE OF RESIDENCE WITHIN WARREN COUNTY NEW JERSEY:

If you are a WARREN COUNTY REGISTERED VOTER who has received a Confirmation Notice, or have moved WITHIN WARREN COUNTY AND DID NOT NOTIFY THE ELECTION BOARD on or before the address change deadline of **MAY 12, 2026**: **1)** if you have moved **WITHIN your current voting district**, you may vote at your usual polling place after filling out a form available at your polling place to update your voting records; **2)** if you have moved **outside of your former Warren County New Jersey** voting district **but still within Warren County New Jersey**, you are permitted to vote by Provisional Ballot at the polling place assigned for your new and current residence in Warren County. Such a WARREN COUNTY REGISTERED VOTER may contact the Election Board at 475-6312 or 6313, OR their local municipal clerk to determine their **NEW** polling place.

CHANGE OF RESIDENCE FROM ONE NEW JERSEY COUNTY TO ANOTHER:

If you are a New Jersey registered voter who has moved outside of your County, but still within the State of New Jersey within 21 days of the election, you may return to your former New Jersey county/polling place to vote. Then you must register in your new New Jersey County.

Pursuant to provisions of the Voting Accessibility for the Elderly and Handicapped Act of 1984 (P.L. 98-435), a telecommunication device for the deaf (TDD) is maintained at the Election Division, Department of Law and Public Safety, Trenton, New Jersey. Persons wishing to utilize this service to obtain general voter information, may do so by dialing **1-800-292-0039**.

Any person who is unable to vote due to blindness, disability or inability to read or write may bring someone to the polls to assist them; you may also be assisted at the polls by district board workers. You may also use the voice recorded ballot on the voting machine which allows for independent voting by the blind and visually impaired.

You have the additional option of applying to the WARREN COUNTY CLERK (908-475-6211) for an MAIL-IN BALLOT. **MAIL-IN BALLOTS ARE AVAILABLE TO BE USED BY ALL VOTERS**

Mail-In Ballots may be returned to the Warren County Board of Elections via the United States Postal Service, In-Person at the Warren County Board of Elections Office (with ID) located at 202 Mansfield or place them in a Warren County Mail-In Ballot Drop Box at the following locations:
